1. Information on how to enter forms part of the terms and conditions of entry to this game of skill promotion. Entry into the promotion is deemed acceptance of these terms and conditions.
2. The Promoter is Fox Interactive Media, Level 7, 241 Commonwealth Street, Surry Hills NSW 2010. ABN: 27 122 967 239.
3. The promotion commences at 1.00pm (AEST) on 8 July 2009 and closes at 9.00am (AEST) on 20 July 2009. ("The Promotion Period").
4. Entry is open to Australian residents. ("Eligible Entrants")
5. Directors, management, employees, officers and immediate families of the Promoter and its related bodies corporate, employees of associated agencies involved in this promotion are ineligible to enter this promotion.
6. To enter the Marilyn Manson Giveaway competition, entrants must enter in the comments section of the website their answer to this question: "If you could go on tour with Marilyn Manson, anywhere in the world, where would you go and what would you do?". All entries must be be 25 words or less.
