**Myspace "Rock of Ages" Giveaway Sweepstakes  
Official Sweepstakes Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

The following promotion is intended for participants in the United States only and shall be construed and evaluated according to the laws of the United States. Do not proceed in this promotion if you are not a legal resident of the United States. Further eligibility restrictions are contained in the official rules ("Official Rules") below.

- 1. DESCRIPTION:** The "Rock of Ages" ("Sweepstakes") begins on or about June 4, 2012 and ends on June 18, 2012 at noon Pacific Time ("PT") ("Sweepstakes Period"). - 2. By responding to the Sweepstakes question or prompt, the Entrant will automatically receive one (1) entry into the Sweepstakes.
