



**MYSPACE "Size in the Park 2" TICKET SWEEPSTAKES  
Official Sweepstakes Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

The following promotion is intended for participants in the United States only and shall be construed and evaluated according to the laws of the United States. Do not proceed in this promotion if you are not a legal resident of the United States. Further eligibility restrictions are contained in the official rules ("Official Rules") below.

**1. DESCRIPTION:** The "Size in the Park" Sweepstakes (the "Sweepstakes") will begin on or about 9:00am PDT, September 23, 2013 and will run until approximately 9:00am PDT on September 26, 2013 or until such time as all prizes have been awarded, in Sponsor's discretion ("**Sweepstakes Period**"). The Sweepstakes is sponsored, administered and fulfilled by Myspace LLC, 407 North Maple Drive, Beverly Hills, CA 90210 ("**Sponsor**" or "**Myspace**").

**2. HOW TO ENTER:** To enter the Sweepstakes, users must log onto their Myspace profile, then "Connect" to the "Mix" on Steve Angello's Myspace profile page located at <https://myspace.com/steveangelo/mixes/win-free-tickets-to-see-steve-at-size-in-the-park-nyc-9.27-205137>. Each Myspace account user may enter the Sweepstakes only once. Sponsor reserves the right to determine which entries have satisfied the entry requirements, in its sole discretion. Each entrant must be the rightful owner (or have authorized use) of the Myspace account utilized in the Sweepstakes. In the event of a dispute as to the identity of any entrant or winner, at the sole discretion of the Sponsor, the entrant or winner will be deemed to be the person in whose name the Myspace account was opened. **POTENTIAL WINNERS WILL BE CONTACTED VIA AN EMAIL MESSAGE TO THE EMAIL ADDRESS ASSOCIATED WITH THEIR MYSPACE ACCOUNT AND/OR THE ENTRANT'S MYSPACE EMAIL INBOX. IT IS THE SOLE RESPONSIBILITY OF THE ENTRANTS TO ENSURE THAT INFORMATION ASSOCIATED WITH THEIR MYSPACE ACCOUNT USED IN CONNECTION WITH THE SWEEPSTAKES IS CURRENT AND ACCURATE.**

**3. ELIGIBILITY:** Sweepstakes is open to legal residents of the 50 United States and Washington, D.C. who are at least 18 years of age in their state of primary residence at time of entry (each, an "**Entrant**"). Entrants must have Internet access or otherwise have an ability to access the Internet as of the start date. All Entrants must be registered members of the www.myspace.com website and in compliance with Myspace's Terms & Conditions policy located at <https://myspace.com/pages/terms>, which may be modified from time to time. Any individuals (including but not limited to employees, independent contractors, consultants and interns) who have, within the last six (6) months, been employed by or performed services for Sponsor or any organizations affiliated with the administration, prize support, fulfillment, advertisement or promotion of the Sweepstakes (collectively, "**Sweepstakes Entities**") are not eligible to enter or win. Doors open at 5:00pm EDT.  There will be approximately 500 tickets (250 pairs) available for prizing as part of this Sweepstakes.  <i>The approximate retail value ("ARV") of the prize is One Hundred Thirty Dollars (US \$130).</i>

All prize details are at the sole discretion of the Sponsor. Prize winners cannot assign or transfer the prize to another person. No cash alternative is allowed. Prize winners will be notified by email to the email address associated with their Myspace profile. Selected winners will be required to respond (as directed by the Sponsor) to the notification. The failure to respond timely to the notification may result in forfeiture of the prize and the Sponsor will randomly select an alternate winner from among the remaining eligible entries for that prize. **Prize winners' names will be put on a ticket list at the Will Call window at the event venue. All prize winners must have valid ID to claim their prize.** Sponsor, in its sole discretion, may attempt to contact additional potential winners of a prize if any of the prizes remain unclaimed.
